

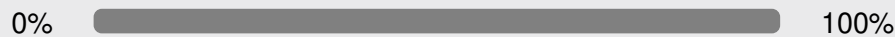

% of Women or non-binary people



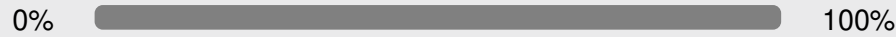

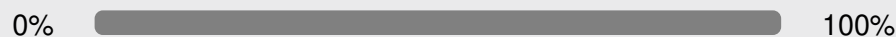

% of leadership in LGBTQ community



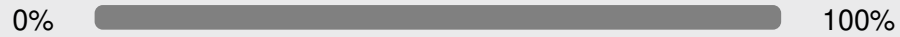
