## RECIPROCAL TARIFF EXCEPTIONS

The reciprocal tariffs do not apply in the following circumstances:

- Goods subject to the savings clause, which requires the goods to be: (1) loaded onto a vessel at the port of loading and in transit on the final mode of transit before 12:01am (ET) on August 7, 2025; and (2) entered for consumption, or withdrawn for warehouse for consumption, before 12:01am (ET) on October 5, 2025. The savings clause does not apply to goods subject to the 10 percent baseline reciprocal tariffs.
- Articles and derivatives of steel and aluminum that are already subject to Section 232 tariffs are excluded.
- Automobiles and automobile parts that are subject to Section 232 tariffs at the time of import are excluded.
- Semi-finished copper and intensive copper derivative products that are subject to Section 232 tariffs are excluded.
- Additional articles listed in [Annex II](#) to the executive order, including copper, pharmaceuticals, semiconductors, lumber articles, certain critical minerals, and energy and energy products, are excluded. On April 11, President Trump [expanded Annex II](#) to include

additional Harmonized Tariff Schedule of the United States (HTSUS) headings and subheadings covering smartphones, computers, and other electronics.

## **TARIFF STACKING**

Tariff stacking occurs when multiple tariffs apply to the same import, creating a cumulative rate that can significantly raise costs. Under the Trump administration's reciprocal tariff regime, new country- or product-specific duties are layered on top of existing tariffs unless explicitly exempted. For example, a U.S. importer of steel from a country already facing a reciprocal tariff could see both the reciprocal tariff and Section 232 steel tariffs applied, unless stacking exceptions are specified. While some rules carve out protections (e.g., exemptions for USMCA-compliant vehicles or prohibitions on stacking with Section 232 metals tariffs), businesses should carefully track product origin, classification, and timing to understand the total effective duty rate they face.

- **Rule** — Reciprocal tariffs add on top of other tariffs, unless an explicit exception applies.
- **Exceptions** — Do not stack on top of Section 232 tariffs, such as those related to steel, aluminum, autos, parts.
- **Savings Clauses** — Many countries exempt goods already in transit before effective dates.
