### U.S. FEDERAL AGENCY SHUTDOWN CONTINGENCY PLANS

#### **EXECUTIVE SUMMARY**

With the federal government having entered into a shutdown due to a lapse in appropriations as of Oct. 1, the Office of Management & Budget (OMB) has issued <u>guidance</u> that agency shutdown contingency plans be hosted on each agency's website, rather than posted on a master list compiled by the White House as previous administrations have done. Below, Thorn Run Partners has compiled a list of government shutdown contingency plans for U.S. federal agencies.

#### **GENERAL GUIDANCE**

- On Sept. 24, OMB issued <u>a brief memorandum</u> to federal agencies with a high-level overview of their plans for a potential government shutdown.
- On Sept. 28, the Office of Personnel Management (OPM) issued a <u>memo</u> entitled "Special Instructions for Agencies Affected by a Possible Lapse in Appropriations." They also issued human-resources focused <u>guidance for furlough workers</u>.
- Rep. Bryan Steil (R-WI), chair of the House Administration Committee, <u>released guidance</u> pertaining to operations of the House during a potential government shutdown.
- Senate leadership also <u>released guidance</u> on their operations during a shutdown hours before the funding deadline.
